

Lobo (Coldstream) Preparative Meeting Minutes. 1895 - 1912

Archives: H-3-2

This minute book is held by the Canadian Quaker Archives and Library in Newmarket, Ontario. It was microfilmed in 1974 and the film can be seen at the Archives of Ontario, MS 303, reel 35.

The transcription was coordinated by Jane Zavitz Bond, archivist for Canada Yearly Meeting, and fully transcribed by Sheila Havard with minor formatting changes for posting by Randy Saylor. The text was transcribed as written so researchers must consider the many variations in spelling when searching the transcribed text. Minor paragraphing has been done to enhance readability. Transcriber notes are in square brackets. The book has not been proof read.

This transcription is donated to the Canadian Friends Historical Association (CFHA). It is made freely available and supports search, cut and paste. CFHA will officially grant linking privileges to organizations that support this free access. CFHA wishes to express its gratitude to those who worked on this project.

Lobo Township is in Middlesex County and situated a few miles west of London, Ontario. The township was settled around 1834 in part by Quakers from the Pelham area and directly from Pennsylvania. In 1849 the growing Quaker community was granted indulged status by Norwich Monthly Meeting. In 1850 the first meeting house was built. Soon the meeting house was no longer adequate and was replaced by the current brick meeting house in 1859 at the small village of Coldstream. In 1857 the meeting became a Preparative Meeting under Norwich Monthly Meeting. Arthur Dorland in his *A History of the Society of Friends (Quakers) in Canada, 1927 & 1968*, states that Lobo Meeting became one of the most progressive centres of the Hicksite Branch of Friends in Canada [172].

In 1893, since Lobo was the most active meeting within the Monthly Meeting it was decided that the name of Norwich Monthly Meeting should be changed to Lobo Monthly Meeting [Dorland, 172]. According to Jane Zavitz Bond, in the 1980's Lobo Monthly Meeting became Coldstream Monthly Meeting and Yarmouth was set off as Yarmouth Monthly Meeting at Sparta. Coldstream is still an active meeting and Coldstream Friends Meeting has a website at coldstreamquakers.com.

The Committee having charge of the First-day School for the past year make the following report –

We the Committee having charge of the First-day School, submit the following the 16th annual report. Our School opened on the seventh of fourth month and closed on the twenty seventh of tenth month. The total enrolment for the past summer is one hundred and one, with an average in attendance of fifty seven and one seventh, a slight increase over last year.

We use Friends' Lesson Leaves as helps in the school.

"Angel of Peace", "Scattered Seeds", "Human Leaflets" and other papers have been distributed during the summer sessions at an expense of \$13.25. Surplus from last year \$2.17 At present there is .92 cts in the Committee's hands for future use.

The Philanthropic work is carried on the same as last year which is an interesting and profitable feature in First-day-School work. The School has been continued in two classes since eleventh month third which have been very well attended.

We would ask that a committee be appointed to have charge of the school another year.

Our School re-opened for the summer term on the fifth of fourth month and closed on the twenty-fifth of tenth month. The total enrolment for the seven months is 103 with an average attendance of 64 a slight increase over last year.

We use Friends Lesson Leaves as helps in the school. The following papers have been distributed in the school viz. "Scattered Seeds" "Angel of Peace", "Northern Messenger", "Band of Hope Review" and "Every other Sunday".

We still continue the Philanthropic Study holding a session at the end of each quarter. We have nine classes in the school one of which is held in London.

There has been expended for papers & postage \$12.33. Cash on hand from last year 92 cts leaving a balance on hand of 59 cts.

The sub-committee appointed by us to have charge of receiving and distributing the First-day School papers handed in by the Scholars report that 312 papers have been received, that 91 of that number were sent to a Sabbath School in Alberta from which a request for such literature was received; 111 to the Protestant Orphans Home in London, and that they purpose sending some to Arkona F.D.S. and some to the Home for

Incurables in London, the expense for postage on the papers has been been 10 cts which was taken from the F.D.S. treasury.

The School during the winter term has been continued in two classes a Bible and an Infant Class.

We the Committee having charge of the First-day-School submit the following report

Our School opened for the summer term on the first of Fourth Month and closed on the thirty first of tenth month.

The total enrollment is ninety six, the average attendance fifty five. Although the attendance is somewhat less than previously we feel that there has been no abatement in the interest taken in the school.

We have nine classes at present, one of which is held in Guelph at the home of Charles A. Zavitz, The London class was kept up through the winter until the end of fifth month when it ceased owing to the removal of the class from London.

We use Friends Lesson Leaves in the school. One class use the Intermediate, and the Infant Class is taking up the lessons published in Scattered Seeds.

We have distributed the following papers in the school Scattered Seeds Northern Messenger, Every Other Sunday and weekly welcome.

We still continue the Philanthropic holding a session at the end of every quarter, and find them interesting and some practical work is claiming our attention.

There has been expended for papers postage etc \$8.82 eight dollars and eighty two cents, balance on hand from last year (.59) fifty nine cents leaving a balance in the hands of the Committee of (\$3.77) three dollars and seventy seven cents
