Archives: This marriage register is held by the Canadian Quaker Archives and Library in Newmarket, Ontario. It is stored in Box 41, item 9. The fonds is also described as O-41-item with the O standing for Orthodox.

Botsford St Friends Church in Newmarket was also called Yonge St Meeting and Newmarket Meeting. In 1881, the Orthodox Canada Yearly Meeting separated into Evangelical (church service) and Conservative (silent worship) branches. At Yonge St, the Conservative branch maintained the original 1812 Meeting House and was designated Yonge St Conservative. The Botsford St Friends Church was designated Yonge St Orthodox with an Evangelical church service and they were the other part of the separation establishing their church in Newmarket. The Church Friends received the burying ground on Yonge St. Both monthly meetings were named Yonge Street Monthly Meeting, claiming legal and theological continuation to the original meeting body.

This Register was deposited along with all the Botsford St. Mtg. minute books in the CYM Archives in the early 1980's, by Marjorie Moore Keffer, clerk at the time, when the Botsford St meeting was laid down. Box 41 was created at that time. It was microfilmed, with other Botsford St records, but not part of the 1975 microfilming.

This transcription was originally posted on the Canadian Yearly Meeting Archives web site under the title *The Marriage Act 1937*. By agreement it is now posted to the Canadian Friends Historical Association (CFHA) web site with a different title. It is made freely available and supports search, cut and paste. CFHA will officially grant linking privileges to organizations that support this free access.

THE MARRIAGE ACT [R.S.O. 1937, chapter 207)

Registration of Marriages

30. Every clergyman, minister, or other person authorized to solemnize marriage, shall, immediately after he has solemnized a marriage, enter in a register to be kept by him for the purpose, unless a similar register is kept in the church at which he officiates, in which case the entries shall be made in that book, the particulars mentioned in Form 4, and shall authenticate the same by his signature.

31. (1) Every clergyman, minister, or other person authorized to solemnize marriage, where a marriage register is not already possessed by any church or congregation over which he is placed or has charge, shall make application for a register to the clerk of the local municipality within which the church or congregation is situate, and the clerk shall thereupon supply such regsiter, at the cost of the municipality.

(2) One additional register may be supplied, at the cost of the municipality, to any clergyman, minister, or other person authorized to solemnize marriage, and a register shall also, on application, be supplied at the like cost to any clergyman or minister in the municipality who is not in charge of a church or congregation.

(3) Every clergyman or minister in charge of a church or congregation in an unorganized township shall, upon a written application to be made by him to the Registrar-General, receive a register, to be supplied by the Registrar-General.

32. The register, by whomsoever furnished, shall be the property of the denomination or body to which the clergyman, minister, or other person, to whom it is delivered, belongs at the time of the delivery thereof, and where he is in charge of a particular congregation of such denomination, it shall belong to the trustees or other body in which the property of the church or meeting house used by such congregation for its ordinary services is vested.
