The text was transcribed as written so researchers must consider the many variations in spelling when searching the transcribed text. Minor paragraphing has been done to enhance readability. Transcriber notes are in square brackets. The book has not been proof read.

Orthodox Friends began this minute book after the separation in 1828. The Hicksites kept and continued to use the pre-separation minute book. The last few pages of this book contain a list of the books in the Friends Library and one page of Books Lent.

By the mid 1790's a number of Quakers, mostly from Pennsylvania, had settled in the Niagara area. In 1799, the Philadelphia Yearly Meeting approved the establishment of Preparative meetings at Short Hills in Pelham Township and Black Creek in Bertie Township and one day later Pelham Monthly Meeting was established. The meeting house was rebuilt to be larger in 1807. In 1810 the Canada Half Yearly Meeting was established under New York Yearly Meeting with Pelham, Yonge St and Adolphustown being the Monthly Meetings. Norwich became a Preparative Meeting under Pelham in 1816. Upon the separation in 1828, the Hicksite branch of Pelham came under Genesee Yearly Meeting in 1834.
