Halcyonia Monthly Meeting, Book B 1918-1935

Archives: This minute book is held by the Canadian Quaker Archives and Library in Newmarket, Ontario in Box 101 (S-101-2).

Fritchley Meeting is in Fritchley, Derbyshire, England and is still an active meeting. Several Fritchley Quakers established Halcyonia Meeting in Borden, Saskatchewan in 1903. They were part of a western group of meetings in Alberta and British Columbia that met annually. The Halcyonia Meeting is now named the Borden Meeting of Conservative Friends and remains an active conservative meeting. Jane Zavitz Bond states that the meeting had an association with the Ohio Yearly Meeting. She adds that the first minute book, Book A, has been lost.

To the Members of the Appeal Tribunal under the Military Service Act From the Halcyonia Monthly Meeting, of Friends, commonly called 'Quakers'.

This our friend Thomas Henry Clarke although not a member has been a regular attender of our meetings for $5\frac{1}{2}$ years.

He has sacrificed better pecuniary opportunities so as to be near Friends & is considered as one of us. He is convinced of our principles with regard to our objection to all war & cannot take part in any preparation for or assist in Military operations. He has been disfranchised on account of his concientious objections, under the War Time Election Act.

He is at present working on a farm & considered essential, being the only hired man on a large farm with 500 acres under crop this year.

He is fully aware of the consequences of disobeying Military orders, but is prepared to suffer rather than wrong his conscience.

We believe in fully obeying the injunction of the Lord Jesus: – 'Love your enemies do good to those that hate you & pray for them that despitefully use you? We are prepared to suffer for our principles, but cannot betray them. Our young men are being called up & we desire them to be faithful to their convictions, & if they suffer we also suffer with them.

On no account can they take up arms to kill their fellow men, or in anywise assist others to do so.

We desire to obey the laws of the land, in so far as they do not conflict with the higher law of God that we are convinced of in our own hearts & against which we cannot go & we think farming is as essential as anything in which we could be employed.

We realize the gravity of the present crisis but we feel forbidden to take up carnal weapons under any [consideration] & feel it best to do what we believe to be right & trust in Devine protection.

3rd Query: We believe Friends are preserved in love towards each other. Differences have arisen amongst us & we are endeavouring to end them, to the satisfaction of Friends. We feel that there is a need for more care to refrain from tale-bearing and detraction.

4th Query: We believe most Friends endeavour by example & precept to train up their children & those under their care in a religious life & conversation consistent with our christian profession, in the frequent reading of the Holy Scriptures & some Friends in plainness of speech, behaviour & apparel, others in a good degree of Christian simplicity.

5th Query: We believe Friends are just in their dealings & endeavour to be punctual in fulfilling their engagements. They are annually advised to inspect the state of their affairs once in the year.

6th Query: Friends are careful to avoid vain sports & places of divertion. There have been some exceptions but on being spoken to have expressed a resolve to [prefrain] from an recurrance.

8th Query: We believe Friends are faithful in our testimony against bearing arms & being concerned in the malitia, privatiers letters of Mark, or armed vessels or dealing in prize goods.

11th Query: No meetings have been settled, discontinued or united since last year.

13th Query: Care is taken to admonish such as appear inclinable to marry contrary to the rules of our society.

8th minute: The answers to the Queries have been read. The clerk is requested to take them to the yearly Meeting. Joseph Hinde Clerk.

9th minute: We are informed that Lawrence Crabb & Hannah Mary McCheane have accomplished their marriage in a manner contrary to the rules of the Society. The overseers are requested to take the matter up & report to the next Monthly Meeting

10th minute: The Yearly Meeting is proposed to be held at Halcyonia on the 3/7/1918 at 11 am at the Thistledale Meeting House.

11th minute: The next Monthly Meeting is proposed to be held at the Meeting House Thistledale on the 31/7/1918 at 11 am.

12 minute: The minutes of last Monthly Meeting have been read.

13 minute: A concern has been felt that we cannot but testify as a meeting against the writings of Mary Baker Eddy on so-called Christian Science, as being full of false & dangerous doctrines & we desire to warn Friends against them.

Dear Friends,

From FRITCHLEY GENERAL MEETING OF FRIENDS, held at Fritchley, (England) on the 30th of Fourth Month and the 1st of Fifth Month, 1930, to the Meetings of Friends with which we correspond on the American Continent and elsewhere.

DEAR FRIENDS,

Met again as a General Meeting, few in number and sensible of our weakness, we feel to salute you in grateful response to the loving messages of sympathy and counsel received from you, which have been read to our comfort and encouragement.

It was the complaint of the Lord's prophet formerly that the ways of Zion mourned because none (or few) came to her solemn feasts, and we feel there is similar cause for morning now in this our once highly favoured land, where the light of the glorious gospel-day broke forth among our first Friends in such primitive power and brightness that George Fox declared that "one living in the virtue and power of it would shake the country for ten miles round."

"I cannot forget" says Wm. Penn "the humility and chaste zeal of that day. O, how constant at meetings, how retired in them; how firm to truth's life, as well as truth's principles, and how entire and united in our communion, as indeed became those that profess one head, even Christ Jesus the Lord.

This was the secret of their power, and only by reliance on the same means can we hope for a fresh outpouring of the Spirit, so that, as in Ezekiel's vision, there may be a shaking of the dry bones, a coming together of bone to bone, a covering with sinew and flesh, and an inbreathing of divine breath, that they may live and stand upon their feet, an exceeding great army. "With men this is impossible, but with God all things are possible."

In view of the evident confusion at the present day among many under our name as to the true faith of our Society, we desire lovingly, to remind Friends with you and with us, those of the rising generation especially, of the following beliefs which we regard as fundamental to the Christian profession:

- 1. That God, the supreme object of worship, is an objective reality, in us, as "the true Light which lightest every man," but not of us, and no mere subjective creation of man's imagination.
- 2. That, as Isaac Penington declared "religion is a sensible plant and not a knowing mind," and that to be able to distinguish between the motions of our own spirit, and those of the Lord Jesus Christ in our heart is an elementary Christian necessity. As our Saviour said "My sheep hear my voice and they follow me."

- 3. Although constant watchfulness unto prayer is the duty of every Christian, yet, again quoting from Penington "Prayer is wholly out of the will of the creature, wholly out of the time of the creature, wholly out of the power of the creature." The least inclination to good springs from a higher source than our own nature and saving faith is the gift of God, for without Christ we can do nothing and all our sufficiency is of God. As has been truly said by one not a Friend, "The knowledge of our nothingness is a great step in religion."
- 4. Unless unavoidably prevented, it is our imperative duty, as it is our great privilege to meet together for the purpose of Divine worship, though the mere meeting together is not in itself worship, but preparatory thereto. We cannot, however, prescribe the form spiritual worship may assume, whether it shall be a living silence, or vocal, as in testimony, prayer or thanksgiving. Programmed meetings specially appointed for any of these purposes show a misunderstanding of the basis of true worship and are an assumption of Christ's prerogative as the alone Leader and High Priest of his people.

Music and singing in worship and the use of symbolical representations which inevitable lead to an outward priesthood, now for ever done away in Christ, are of a retrograde character, and to the rightly exercised and enlightened mind are hindrances and not helps.

We wish earnestly to recommend and encourage the diligent reading of the writings of our early Friends as second only in importance to the Holy Scriptures. They were an inspired people, and most of what they have left on record is as applicable to to-day as to the time when it was written. It was, we believe, largely ignorance of our own history, and of the teachings of experienced Friends that led to the great confusions among professing Friends during last century in America, particularly that almost wrecked the Society. Friends' history is Church history above all other since the apostles' day.

Every age has its peculiar perils. Samuel Bownas remarked in his day "the old would extinguish the flame and the young would set the house on fire." It is for each of us to watch our own standing and the signs of the times. Many have been more or less lost to the Church through drifting with the stream and thinking they were not changing. There is no standing still in religion.

May those who feel their poverty, and insufficiency of themselves to do any good thing, remember the encouraging language of Isaiah respecting our Allmightly Helper, "He giveth power to the faint and to them that have no might he increaseth strength"; so let there be a steady going forward that a the end we may be enabled in humility, and in some small measure of faithfulness, to adopt the language of the apostle, "I have fought a good fight, I have finished my course, I have kept the faith; henceforth there is laid up for me a crown of righteousness, which the Lord, the righteous Judge shall give me at that day, and not to me only but to all them also that love his appearing."

We have been afresh encouraged at this time in that the Lord of the vineyard has been pleased to send among us one of his labourers from a distant land whose ministerial service and her exercise of spirit with that of her esteemed companion have been a help and a comfort to us.
