Ferrisburg VT, Mens Preparative Meeting 1793 - 1801

This minute book was filmed by Preservation Resources Inc for Friends Historical Library of Swarthmore College in 1998. Images were provided by <u>Swarthmore College Archives</u> to CFHA in pdf format for transcription. The transcribers were Carman Foster and Moira Greenlee. It was completed August 2015.
